- 2) **Financial Report:** Sent out with Annual Dues Letter to all Residence in December.
  - a) Outgoing funds:
    - i) 2011 payout was minimal with no major projects.
    - ii) 2012 projected budget
  - b) Homes Association Dues:

    - ii) Concerns expressed at Annual Meeting:
  - b) LAO is developed past 90% and the attendees' consensus was that the LAO Homes Association (HA) needs to take over the DRC. It was suggested:

#### **Action:**

- i) Scott Tessmer is to continue additions to site, ongoing no suspense.
- ii) Add Dennis Wilson Disposal Service to utility service providers page. Complete
- iii) Reuse/develop entrance signs to advertise website as the information link for all residents Action lead and suspense: TBD
- iv) Investigate updating format of web site Scott Tessmer / no suspense.

## d) Large Project Planning

i) The topic of 2012 major projects and budgeting was discussed. A general consensus of those in attendance was the maintenance and possible expansion of the trail system, . Specific actions to explore options include:

#### **Actions:**

- (1) Checking with county parks and to determine possibility of connecting to Prairie Green Space. Opinions at the annual meeting were divided so issue will be voted on before actions are taken. Note: LAO plats 7 and 8 indicate there is HA owed space on the south side of the drainage from the lower lake to the Prairie Creek Green Space Scott Tessmer. Suspense: March 2012
- (2) Place ad soliciting estimates for trail repair and resurfacing, bridge repair TBD.
- ii) **Erosion repair** behind at upper lake by lots 185 and 176. Area is associated with storm drainage system and covers an area 8'X40' and up to 3' deep. To prevent impacts to "downstream" locations Additional areas may need to be addressed after repair.

**Action:** TBD **Suspense:** Determine lead and way ahead at Feb Board Meeting.

### e) Potential Projects Identified at Annual Meeting

- (1) The Board is to solicit volunteers for committees and to lead special projects:
  - (a) Local Cub Scouts may support/assist with spring clean up.
  - (b) Volunteers needed for Phone Directory, Garage sale.
    - (i) Actions: Ongoing
- (2) Projects listed brought up at annual meeting. Assignment of leads and timelines to be determined at upcoming Board meetings:
  - (a) Aeration pump wiring repair (upper lake) / move aerator to higher ground.
  - (b) Wiring at north and south entrances for holiday lighting.
  - (c) Revisiting the traffic circle landscaping improvements and evaluate landscaping plants and trees for replacement.
  - (d) Locate LAO HA holiday decorations from early years of development. Likely POCs Scott and Craig Laderoute.
  - (e) Find volunteers for Lakes and Grounds Committee to address pond stocking, upper lake depth survey for (dredging).

#### f) Covenant Issues and Enforcement

Discussion at the annual meeting cover the addressing of Resident Issues and Concerns and the methodology of addressing these issues. Specific concerns were expressed in developing a way to verify issues reported by other residents and addressing issues in

- iii) The Board will continue to look for volunteers for committees and to lead special projects such as leading spring clean up, resident phone directory updates, neighborhood garage sale and other events.
- iv) Association Board structure was being discussed in 2011 as well as By Laws. These topic are currently on hold until we fill all position needed to conduct business.
